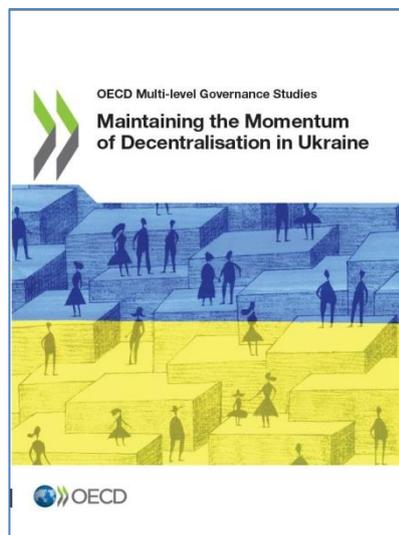

The OECD project runs until June 2018 with the aim of helping the Ukrainian authorities implement their decentralisation reforms and strengthen the institutions of public governance at national and subnational levels across the country. This event will provide a platform to discuss the main recommendations arising from the OECD report *Maintaining the Momentum of Decentralisation in Ukraine*. It will present regional development trends in Ukraine from a macroeconomic and territorial perspective, with a specific focus on growth across regions. With this as a contextual background, the discussions will focus on the main findings and key recommendations regarding Ukraine's current territorial reform, emphasising the advances and opportunities with respect to municipal amalgamations as well as the administrative and fiscal decentralisation processes. The aim is to help Ukrainian authorities at all levels of government gain insight into additional steps that can reinforce the reform process, and discuss an action plan to ensure that the reform process continues to advance with its own momentum.

This event, held with national and subnational authorities in Ukraine as well as other Ukrainian and international stakeholders involved in the decentralisation process, is conducted within the framework of the OECD project on [Supporting Decentralisation in Ukraine](#).

Simultaneous **interpretation in English and Ukrainian** will be provided during the event.
